4. FIRST AID MEASURES

4.1 Description of first aid measures

Additional information ACRYLIC - WATER BASED COMPOUNDS: It should be noted that most water based paints and acrylic or thermoplastic resins may contain small percentage of solvents, usually less than 5%.
